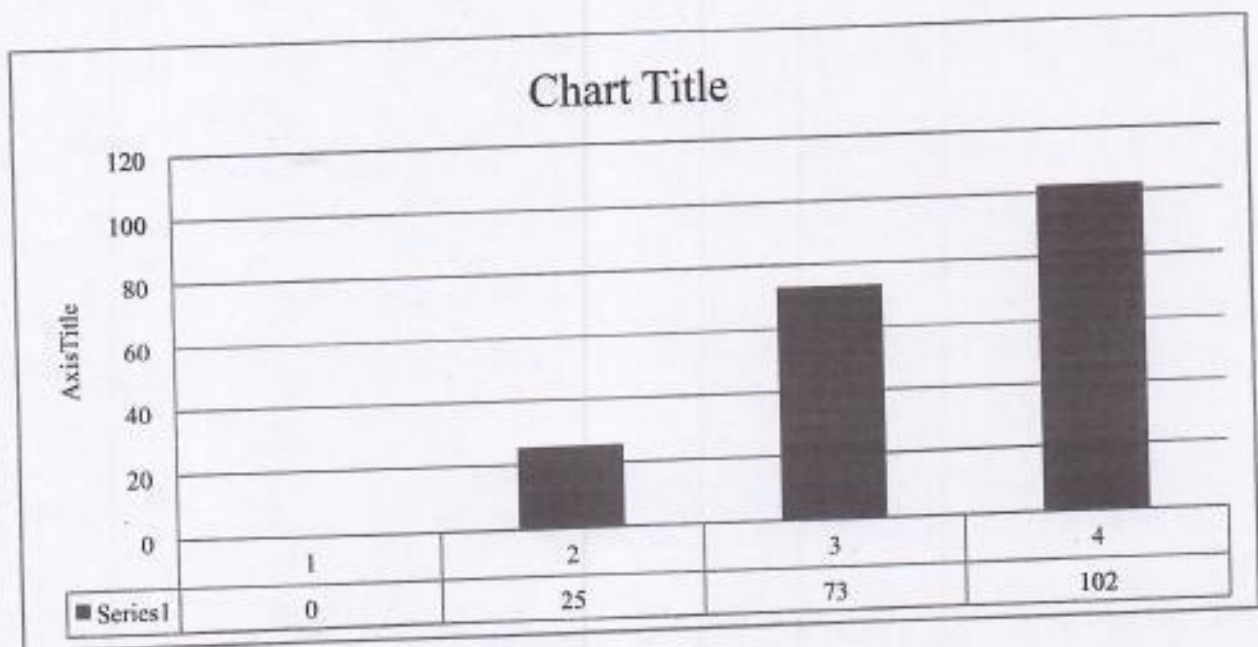

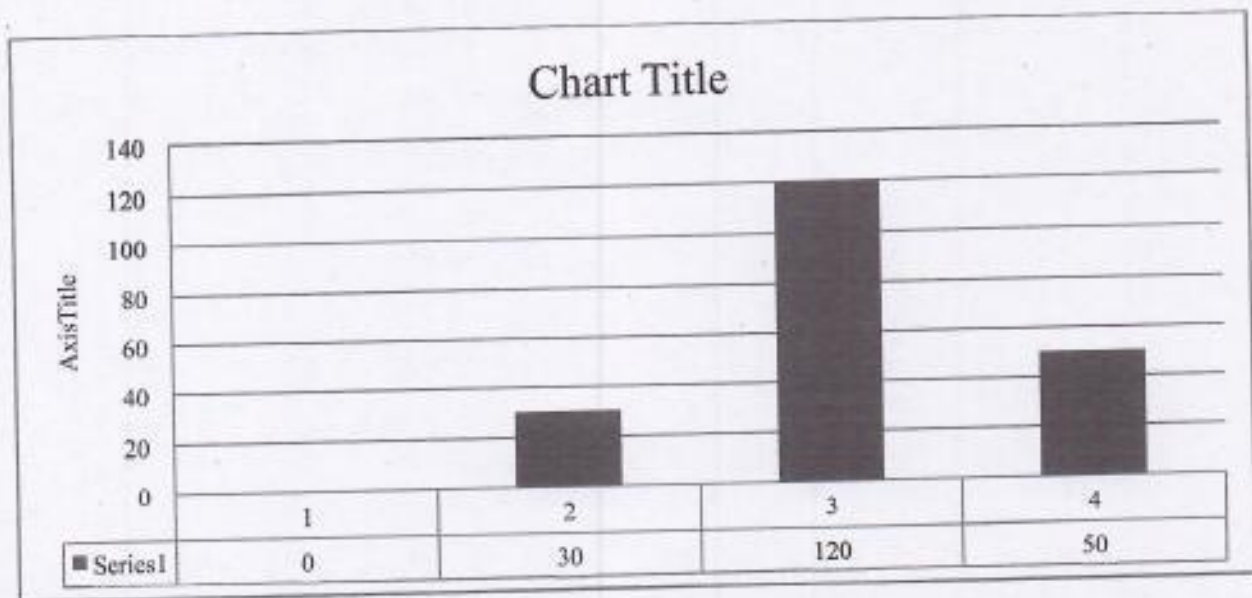

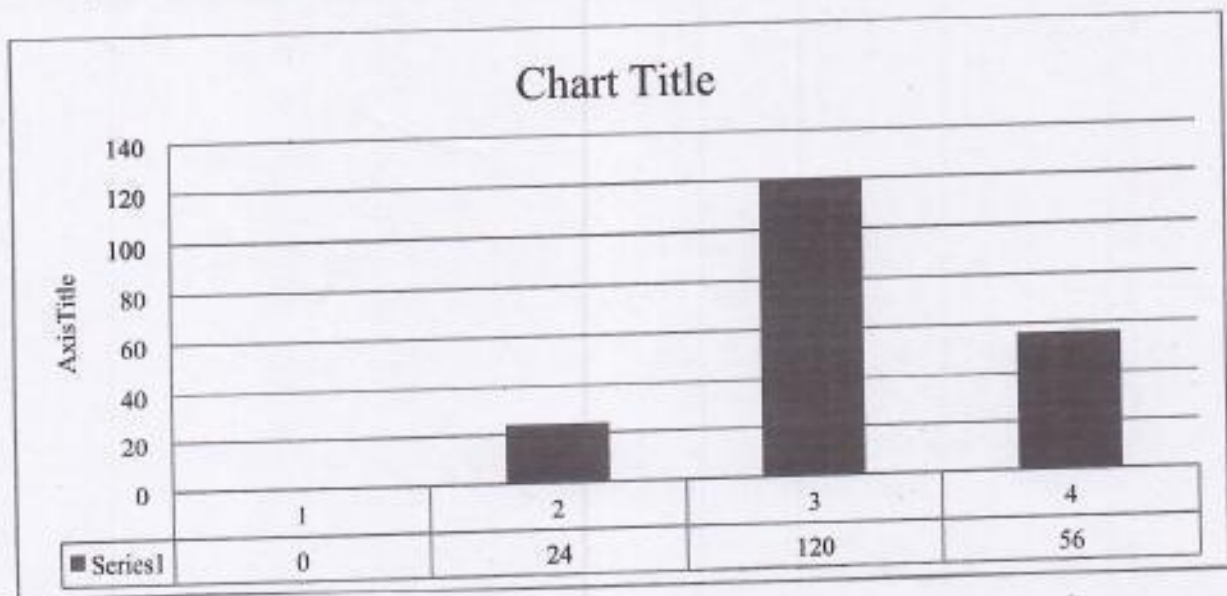


2-How do you rate Program/Syllabus in preparing you for a Job/Higher Studies.



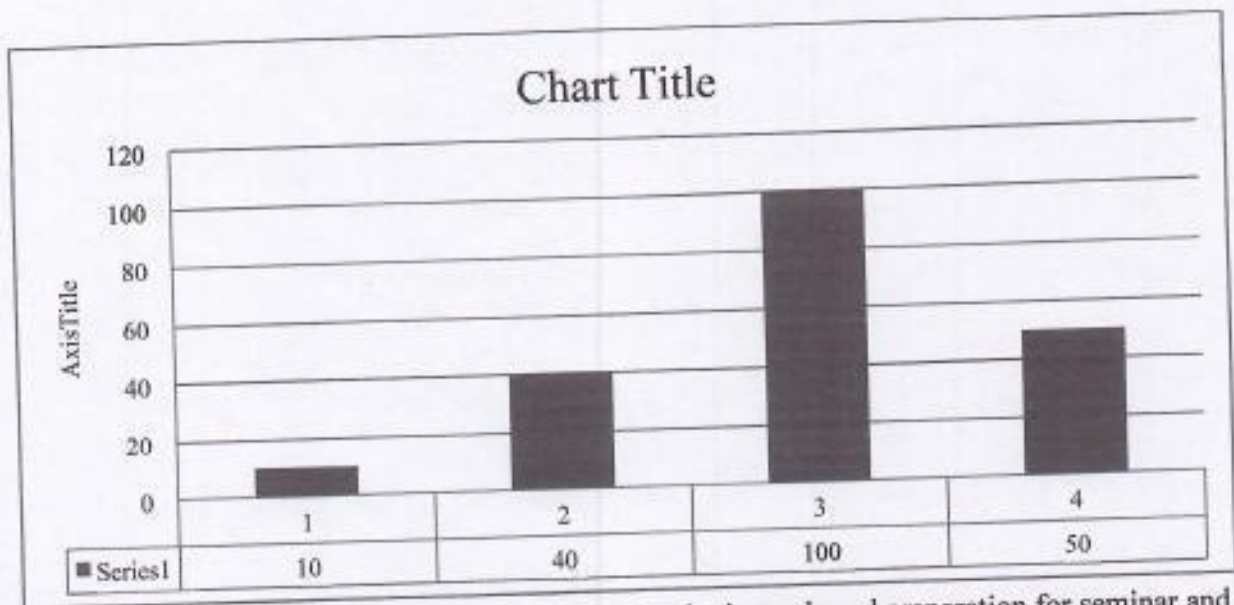

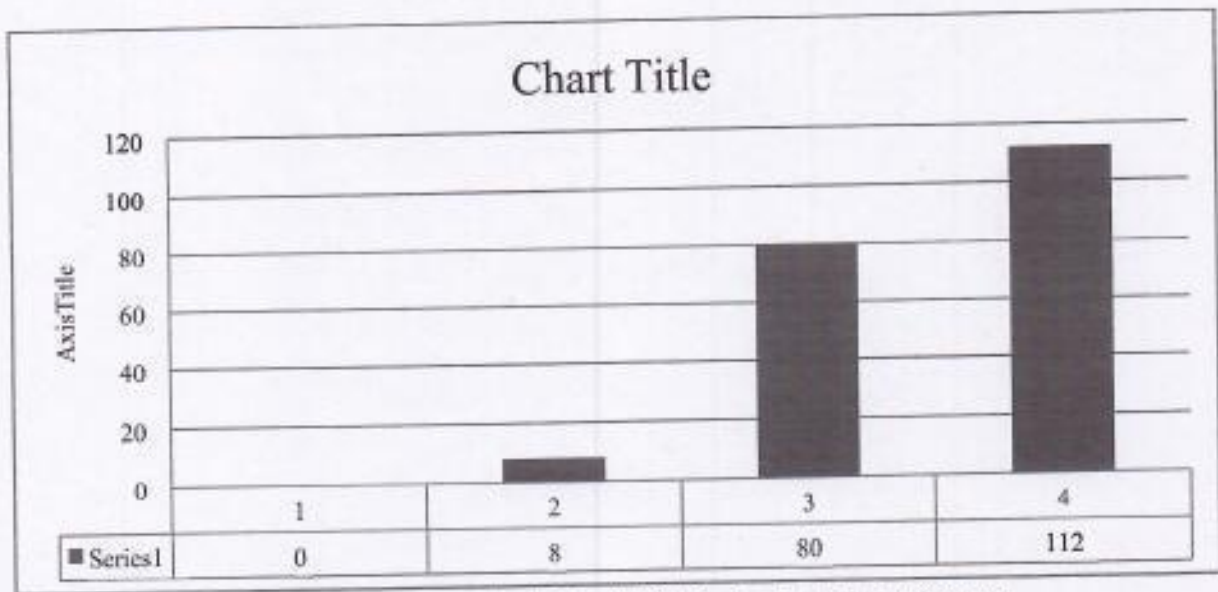

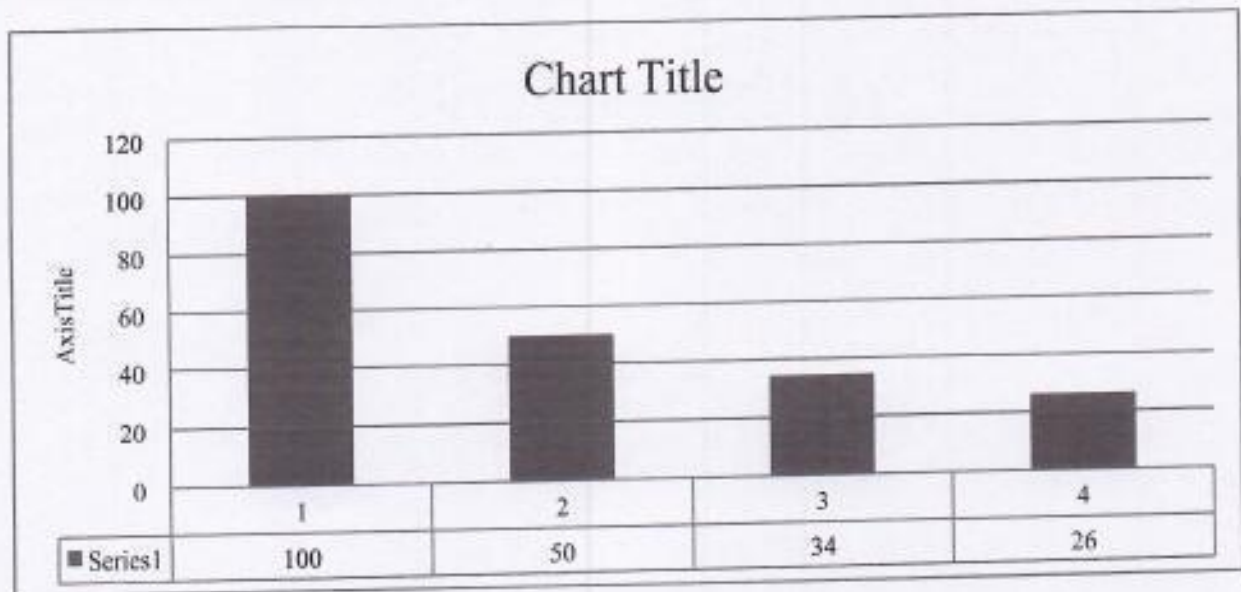


6-How do you rate contribution of the syllabus towards creating awareness about social responsibilities, human values and ethics.



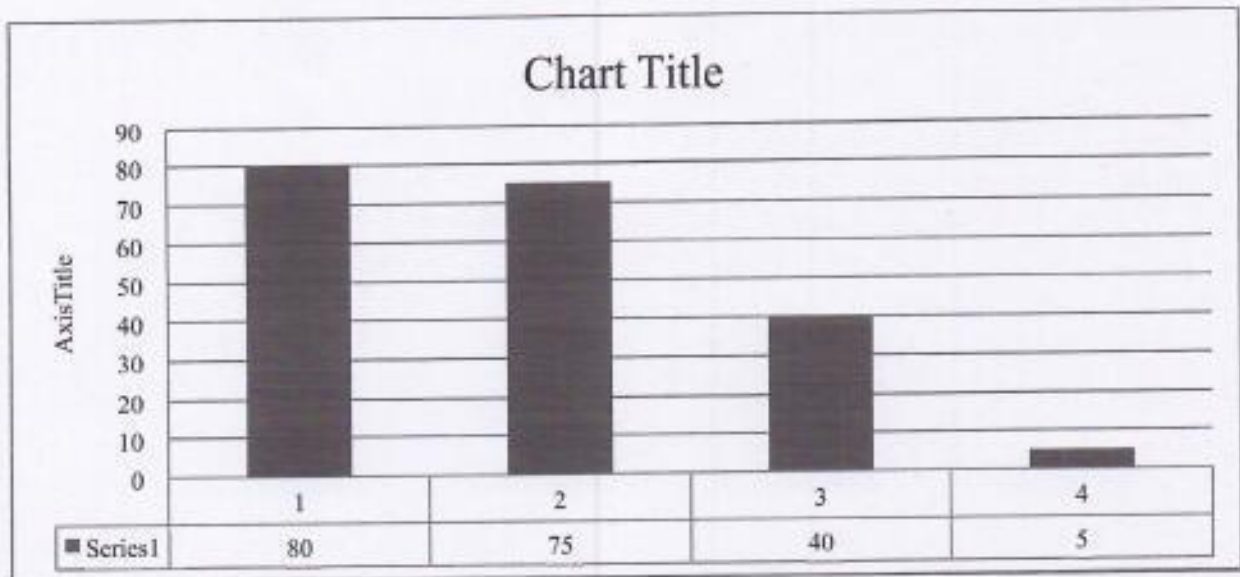


7- Do you feel the existing curriculum/ syllabus fulfill the industrial requirement.

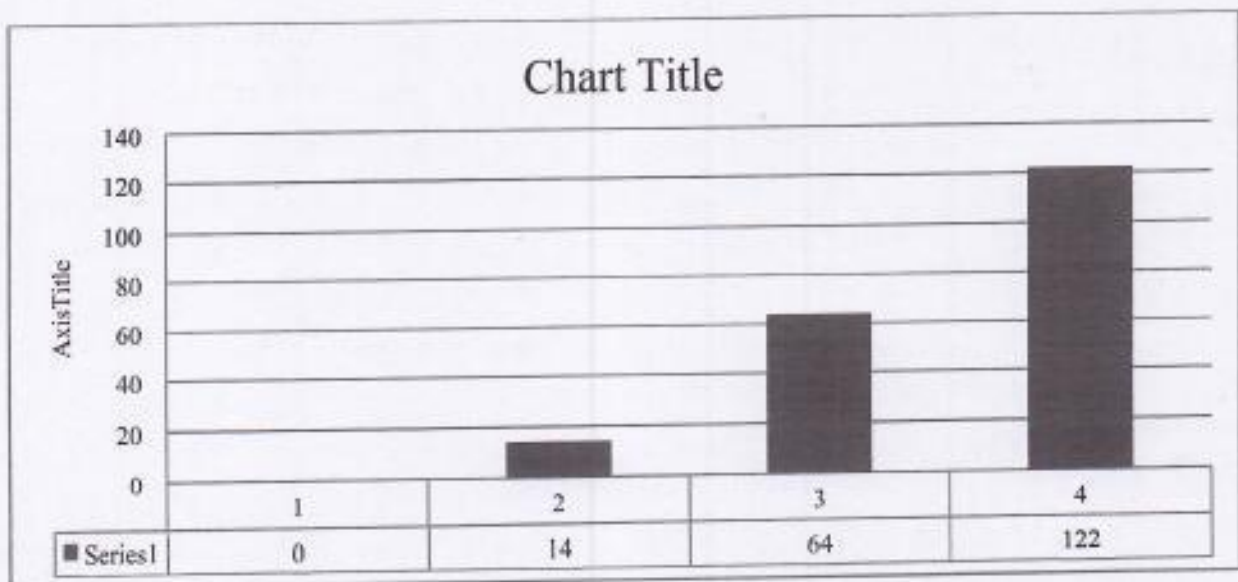


8-Do you feel the curriculum/ syllabus studied is useful now in doing job.
