माननीय कुलपति जी के आदेशानुसार स्वयंसेवक योजना के अन्तर्गत संचालित एलएलएम पाठ्यक्रम में उपरोक्त अभ्यर्थियों को अतिस्टैंट प्रोफेसर पद पर सार्वजनिक/यूजीएसीए/नियामक संस्था के मानकानुसार अनुमोदन इस शर्त के साथ प्रदान किया जाता है कि चयनित अभ्यर्थियों की नियुक्ति महाविद्यालय में उपरोक्त पाठ्यक्रम के संचालन रहने तक उपरोक्त शिक्षकों की सेवाये संतोषजनक रहने तक, रखावत रहेगी। शिक्षकों की शिक्षण गुणवत्ता का निर्धारण करने के लिए मूल्यांकन प्रक्रिया निरन्तरता से अपनाया आवश्यक है। असन्तोषजनक सेवा होने की स्थिति में सेवा सम्बन्धी सविदा का निष्पन्न करने से पूर्व नैतिक न्याय के सिद्धांतों का अनुपालन सुनिश्चित करते हुए विश्वविद्यालय के महाकुलपति का अनुमोदन प्राप्त किया जाना अनिवार्य होगा।

इसके अतिरिक्त यह भी अवगत करना है कि चयनित शिक्षक की मृत्यु/त्यागपत्र की दशा में कमिन्तम 15 दिवसों में विश्वविद्यालय को अवगत कराया जाएगा तथा रिक्त स्थान की आपूर्ति के लिए तुरन्त चयन प्रक्रिया प्रारम्भ करेगे। चयनित अभ्यर्थी केवल एक ही संस्थान में कार्यरत रहेंगे। चयनित अभ्यर्थियों के नियुक्ति प्रमाण पत्र तथा संस्थान में कार्यभार ग्रहण करने सम्बन्धी अभिलेख विश्वविद्यालय को पत्र प्राप्ति के 10 दिवसों में उपलब्ध कराये जाएंगे। चयनित अभ्यर्थियों के अभिलेखों में यदि कोई अनियमितता पायी जाती है तो उसके विरुद्ध विश्वविद्यालय नियमानुसार कार्यवाही करने के लिए स्वतंत्र होगा।
